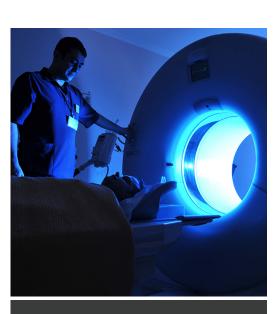

Gemserv joined Teach First and BNP Paribas in a three-year partnership to produce, share and deliver four new school lessons aligned with the curriculum educating young people on net zero and climate issues.

The partnership aims to:

- Focus on closing the attainment gap
- Engage young people in key sustainability issues
- Support pupils from disadvantaged backgrounds

## RETAIL ENERGY CODE CHANGE INPROVEMENT



Retail Energy Code Company (RECCo) and industry have embraced the improvements with RECCo stating 'the Code Manager has responded positively'.

Gemserv took on the role as the Code Manager for RECCo, defining and driving the Change Management Process. It was vital that we created a process that could evolve with innovation in the energy market, and deliver benefits without introducing new challenges.

Through the delivery of a Retail Energy Code (REC) Portal, Gemserv introduced a secure infrastructure for the exchange of critical business information between REC Parties which has become an essential service with over 5,000 registered users.

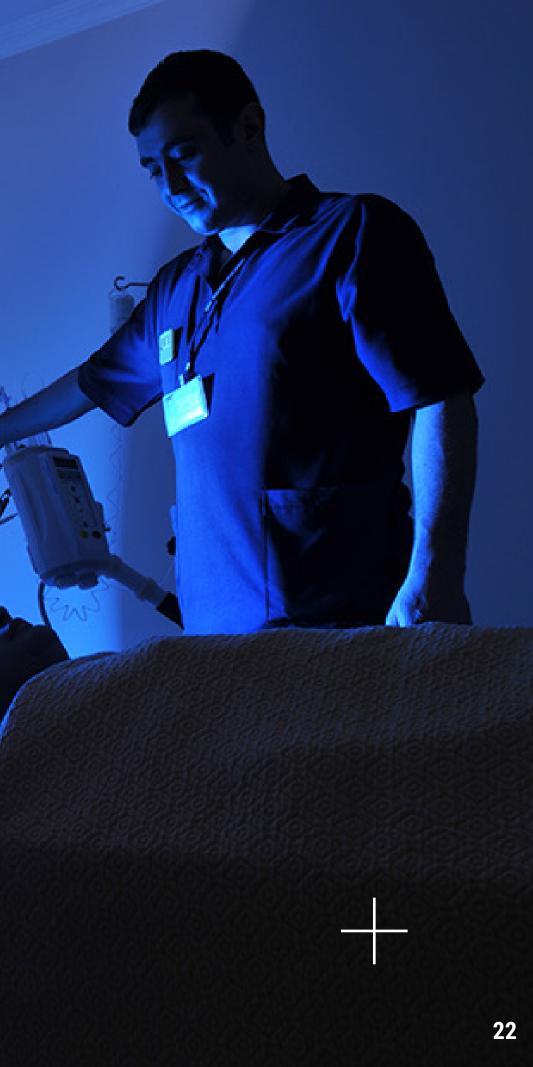

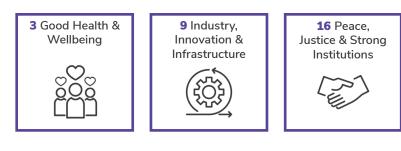

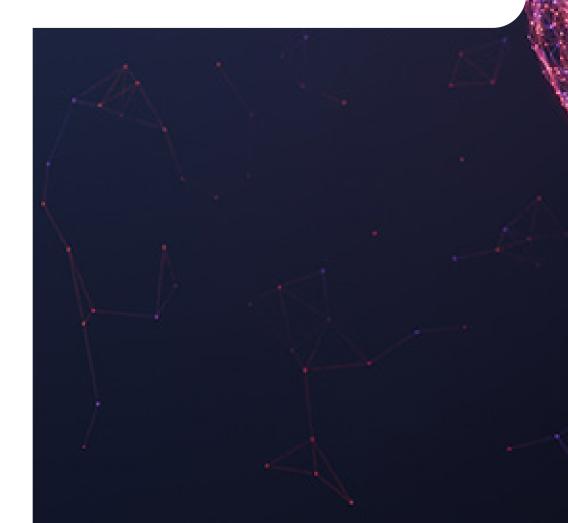
